

POSSESION BY DOCUMENTS

The managing trustee or his nominee or any other trustees if so authorised by the Board of Trustees shall have the custody of all deeds and documents of title relating to the trust property and investments and the books of accounts other records relating to the trust and shall be responsible for the same.

BANKING ACCOUNTS

All income, subscriptions and pecuniary donations for the general purposes of the trust and the income of investments and all other monies for time to time forming part of the general revenue of the trust shall on the same being received be paid into banking accounts with any scheduled banks which the trustees may determine, unless immediately needs for the purposes of the trust.

The banking account or banking accounts may be operated by the Managing Trustee jointly with another trustee as may be determined by the trustees and may also be operated by any person or persons authorised in writing by the board of trustees.
